

OFFICIAL RULES OF THE INCUBUS DOUBLE D8 SWEEPSTAKES

Eligibility: The Incubus Double D8 Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America or Canada (except Quebec) who have a valid social security or tax ID number, who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions.
